"NCITLB & ITP CURRICULUM UPDATES"

PRESENTERS: MARK LINEBERGER & JEFF YORK

THIS WORKSHOP WILL TAKE PARTICIPANTS THROUGH UPDATES TO THE LAWS AND RULES THAT GOVERN THE BOARD. WE WILL ALSO LEARN HOW THE RULES OPERATIONALIZE THE LAW. UPDATES TO INTERPRETER TRAINING PROGRAM (ITP) CURRICULUM WILL ALSO BE DISCUSSED.

"THE STATUS QUO: AN INTROSPECTIVE DIALOGUE"

PRESENTERS: COREY AXELROD & WYATTE C. HALL, PH.D.

WHILE MEMBERS OF THE DEAF COMMUNITY UNDOUBTEDLY BENEFIT FROM HAVING ACCESS TO SIGN LANGUAGE INTERPRETERS, THE PROVISION OF INTERPRETING SERVICES DOES NOT ALWAYS ADDRESS THE OVERARCHING NEEDS, ESPECIALLY WITH GROWING DISCUSSION OF THE IMPLICATIONS AND IMPACT OF LANGUAGE DEPRIVATION, OF THIS COMMUNITY. IN ORDER TO CONCEPTUALIZE AND ACTUALIZE HOW TO BEST MOVE FORWARD, WE NEED TO ASK THE FOLLOWING QUESTION: HAVE INTERPRETERS CORNERED THE DEAF COMMUNITY? THIS IS A TOUGH, BUT MUCH NEEDED INTROSPECTIVE CONVERSATION AND ALLOWS US TO DISCUSS WHETHER THE STATUS QUO ACTUALLY RESULTS IN EXCEPTIONAL INTERPRETING EXPERIENCES FOR DEAF CHILDREN IN K-12 SETTINGS AND ADULTS IN EVERYDAY SETTINGS. PRESENTERS COREY AXELROD AND DR. WYATTE HALL WILL GUIDE PARTICIPANTS THROUGH THIS DISCUSSION AND TAKE A DEEP DIVE INTO THE STATUS QUO WITH AN EMPHASIS ON RESEARCH AND DISCUSSIONS ABOUT LANGUAGE DEPRIVATION IN DEAF COMMUNITIES, AND HOW INGRAINED INTERPRETING PRACTICES CAN IMPACT VARIOUS POPULATIONS.
